## **2005 – 2006 Roy Lee Smith SIFE Scholarship**

**Contribution of \$3,500 by Mr. and Mrs. Roy Lee Smith to the Georgia Southwestern State University Foundation has made it possible to award 5 to 7 scholarships in the amount of \$250 - \$700 per academic year (\$250 – 350 per semester) to Students in Free Enterprise (SIFE) for the 2005-2006 academic year.**

1. Complete the application and return to the Dean of the School of Business Administration
2. Undergraduate applicant must be enrolled in BUSA 4405 – Free Enterprise in Practice I or BUSA 4406 – Free Enterprise in Practice II
3. Graduate student must be enrolled in BUSA 6045 – Graduate Course in Free Enterprise I or BUSA 6046 – Graduate Course in Free Enterprise II
4. Student who completed Free Enterprise courses and would like to continue to be an active SIFE member will be considered, but priority is given to those who are enrolled in SIFE courses. An active SIFE member must perform at least 50 hours of SIFE activities per semester.
5. Undergraduate students must have a cumulative GPA of 2.80 or better, while graduate students must have a cumulative GPA of 3.00 or better.
6. Recipients must be committed to SIFE for the entire academic year.
7. Recipients will be selected by a committee of faculty of the School of Business Administration. Selection from applicants who have satisfied the minimum requirements for eligibility will be made on the basis of selection committee judgment as to probability that the applicant will reflect favorably on the School of Business Administration and the University in academic, and leadership ability. Recipients will continually be reviewed.
